

FINANCIAL GUARANTEE FOR INTERNATIONAL STUDENTS

FUNDS NEEDED

- UAT's Undergraduate tuition is \$12,475 per semester in which the student is enrolled.
- UAT's Graduate tuition is \$8,750 per semester in which the student is enrolled.
- The non-refundable seat deposit for both programs is \$250
- Books and personal supplies (\$315 Resource Fee for both programs) are the responsibility of the student each semester

FUNDS NEEDED FOR U.S. HEALTH INSURANCE

International students are required to carry adequate health insurance while studying in the U.S. You will be responsible to pay for the insurance plan while you are enrolled in the institution. If you take a Leave of Absence (LOA), you must continue coverage during this time.

Proof of a current health insurance policy is required to be provided to the University of Advancing Technology prior to enrollment and must remain active throughout any enrollment at the University.

CERTIFICATION OF FINANCIAL SUPPORT

Evidence of guaranteed financial support showing sufficient funds are available for the required course of study, health insurance and living expenses must be submitted to University of Advancing Technology.

Evidence of guaranteed financial support is a requirement of the U.S. Department of Homeland Security
